

ORDINANCE NO. 1972--1

AN ORDINANCE MAKING APPROPRIATIONS TO DEFRAY
ALL NECESSARY EXPENSES OF THE TRI-TOWNSHIP PARK DISTRICT
AND OF THE BOARD OF COMMISSIONERS OF THE SAID PARK
DISTRICT, MADISON COUNTY, STATE OF ILLINOIS, FOR THE
FISCAL YEAR BEGINNING APRIL 1, 1972, AND ENDING
MARCH 31, 1973.

Be It Ordained by the Board of Commissioners of the
Tri-Township Park District, Madison County, Illinois:

ARTICLE I

That the following sums of money, or as much thereof
as may be authorized by law, as may be deemed necessary to
defray all necessary expenses and liabilities of the Tri-
Township Park District, be and the same are hereby appro-
priated for the corporate purposes and objects of said Park
District, as hereinafter specified for the fiscal year
beginning on April 1, 1972, and ending on March 31, 1973.

That all Ordinances or parts of Ordinances conflicting with any of the provisions of this Ordinance be, and the same are, hereby repealed.


ARTICLE VI


That this Ordinance shall take effect and be in full force from and after its passage, approval and publication as provided by law.

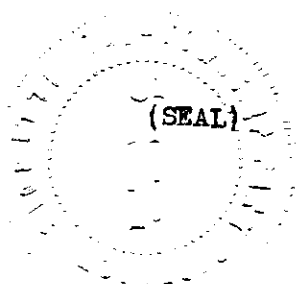
