

ORDINANCE NO. 1974-- 3

AN ORDINANCE MAKING A TAX LEVY FOR THE
TRI-TOWNSHIP PARK DISTRICT IN THE COUNTY OF
MADISON AND STATE OF ILLINOIS, FOR THE FISCAL YEAR
BEGINNING APRIL 1, 1974
AND ENDING MARCH 31, 1975

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS
OF THE TRI-TOWNSHIP PARK DISTRICT:

ARTICLE I. That this Ordinance be and the same is
hereby termed the Annual Tax Levy Ordinance for the Tri-
Township Park District in the County of Madison and State
of Illinois.

ARTICLE II. That there be and hereby is levied and
assessed upon all the real and personal property situated within
the corporate limits of the Tri-Township Park District in the
County of Madison and State of Illinois, the sum of
Ten Thousand Five Hundred (\$10,500.00) Dollars, which said
amount shall be raised by taxation upon all assessed property
according to its value as the same is equalized or assessed
by the Department of Revenue for the year 1974, and which
said amount is to defray the expenses of the Tri-Township
Park District as provided by the Annual Appropriation Ordinance
beginning April 1, 1974, and ending March 31, 1975, as provided
by Ordinance No. 1974-- 2 of said Tri-Township Park District
passed and approved on the 14 day of MAY, 1974, duly
published and according to law by publication thereof in the
Troy Tribune, a newspaper of general circulation within the
said Park District on the 23 day of MAY, 1974, all of
which was done by the Secretary of the Tri-Township Park District,
the said Tax Levy being in detail as follows:


ARTICLE IV. This Ordinance shall be in full force and effect from and after its passage and approval according to law.

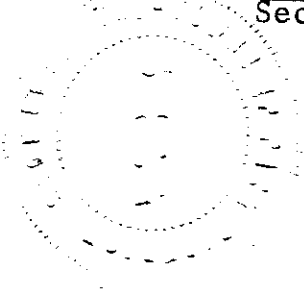




