TRI-TOWNSHIP PARK DISTRICT DOG PARK RULES

The following rules have been designed to protect the humans and dogs that utilize the Dog Park at this location, as well as the property and amenities provided on the site. The Tri-Township Park District asks that everyone utilizing the Dog Park adhere to the rules as written and welcomes suggestions to improve upon the rules and the Dog Park.

- 1. Daily hours of operation are from 6am to 10pm
- 2. Gates must be kept closed except when entering or exiting.
- 3. Dogs outside the fenced area must be leashed at all times.
- 4. All dogs must have current required vaccinations and tags indicating the up-to-date vaccination must be securely fastened to the dogs' collar.
- 5. No dogs under 4 months old.
- 6. No female dogs in heat.
- 7. Dogs must have proof that they are spayed or neutered.
- 8. Dogs that are ill or injured may not use the dog park.
- 9. Dog handlers must be a minimum of 16 years of age and be able to control the dog(s) he/she is overseeing at all times, on or off leash.
- 10. Handlers are limited to a maximum of 2 dogs per visit.
- 11.Children under 8 years of age are not allowed inside the fenced dog park area. All children aged 9 to 15 must be supervised by an adult (18 years or older)
- 12. Food or treats are not permitted. No glass containers are allowed.
- 13. No animals other than dogs are permitted.
- 14. Handlers must "SCOOP THE POOP" left by their dog.
- 15. Handlers must stop dogs from digging and fill holes made by their dog.
- 16. Dogs showing any signs or aggression toward other dogs or humans must be leashed and removed immediately.
- 17. A minimum amount of barking will be tolerated. Excessive barking may be considered a disturbance. Please be considerate of the neighbors.
- 18. Spike or pinch collars are prohibited inside the fenced dog park area.
- 19. Climbing on or over the fence or hanging items on the fence is not allowed.
- 20. Litter must be placed in containers provided. Trash left may end up in a dog's mouth resulting in health problems for the dog.
- 21.No alcohol
- 22.No bikes, scooters, or other motorized vehicles are allowed in or around the dog park.
- 23.Users of this dog park facility do so at their own risk. Neither the Tri-Township Park District, nor any official, employee or agent of the Park District, shall be held liable or responsible for any injury or damage caused by any dog in the off-leash dog park area.
