MINUTES - TRI-TOWNSHIP PARK DISTRICT

The regular monthly meeting of the Board of Commissioners of the Tri-Township Park District was convened at the pavillion meeting room on June 21, 1983 with president Russell Wiesemeyer presiding. In addition to the president, Commissioners answering present to the roll call were Arth, Foucek and Leonard. Attorney Cadagin was also present.

The minutes of the previous meeting were read and approved.

The snapshots taken during the restocking of the lake were left at the Tribune but have not yet appeared in the paper. If not in the next issue, Commissioner Wiesemeyer will take the pictures to the Collinsville Herald.

Commissioner Wiesemeyer noted that the reapplication to the Department of Conservation for funding assistance on the land on the southwest corner of the Park has been submitted on June 15, 1983. The only necessary changes to the original application was an update on the appraisal which Thompson stated was consistent with the prior year.

Commissioner Wiesemeyer contacted Howard Knecht regarding his bid on blacktop sealing and repair which arrived two days after the last meeting. It appeared to be excessive and Knecht was asked to resubmit - no further response. Norman Kirsch has been asked to submit a bid when he prepares the Jarvis Township bid.

Commissioner Wiesemeyer received a call from Kay Brendel, who was dissappointed with the condition of the pavillion. One other complaint was also received from Peggy Llewlllyn. Kay Brendel suggested that Girl Scouts and Boy Scouts could earn community activity points by doing clean-up work on the pavillion. Subsequent to discussion Commissioner Leonard moved that Girl Scouts and Boy Scouts be authorized to police area subject to clearance with Mr. Semanisin. Motion was seconded by Commissioner Arth and carried. Kay Brendel will be notified to proceed with the project.

The Treasurer's Report was read and the bills were presented. Motion to accept Treasurer's Report and pay bills was made by Commissioner Arth, seconded by Commissioner Foucek and carried.

Attorney Cadagin provided a lease agreement for the trailer tenant. Additions were made by the Board. Motion to approve the lease agreement as corrected was made by Commissioner Foucek, seconded by Commissioner Leonard and carried.

Attorney Cadagin said he would discuss the tax levy at the July meeting.

Assessed valuation on Tri-Township Park District tax district was provided by Evelyn Bowles. Assessed value - \$44,607,288. Tax rate - .068.

Motion was made by Commissioner Foucek, seconded by Commissioner Arth and carried to authorize Commissioner Leonard to call in another worker to assist Mr. Semanisin.
