Mr. Qualls has been getting quotes on the tennis courts and looking at replacing the fountains that are not working correctly.

Office Manager: Sandy Pensoneau reports that the Easter Egg hunt went very well, we had over 1000 people in the park for the event, we are making a few adjustments to the hunt for next year. Sandy also reports that she is finishing end of year numbers and getting ready for our yearly audit.
